**CONTRACT PROVISIONS**

The dealer table assigned to each member cannot be sold, rented, loaned or leased by any other individual during the convention without the approval of the Convention Chairman.

The cancellation of the rental agreement or failure to appear for the Show and may result in the loss of all payments. If a table can be resold a credit will be issued to the original dealer for the following show.

It is understood that the SNCCC / LVABCC does not provide insurance against any damage or loss suffered by fire, theft, accident or personal injury.

Table priority for the Show will be on a first come , first call basis. Upon receipt of this Contract and full payment you will be contacted to confirm any preference you may have as to location of your choice. You will be given 3 days to confirm

All dealers are required to keep their table(s) open, and wares displayed for the **FULL HOURS OF THE SHOW**. There will be no breaking down table space early. Any dealer who violates this provision may be banned from future Conventions or face other sanctions.

The Convention Chair(s) reserves the right to expel any dealer or individual who conducts himself or herself in a manner deemed unbecoming to our organizations, in such event, there will be no refund of table fees.

NEVADA DEPT. of TAXATION: We are required to provide a list of all Dealers at our Show. At the Show, you will receive a Nevada State Dept. of Taxation form that you will be required to fill out and return to the designated Show Representative by the end of the Show. If you do not fill out and return the form, you will be in violation of the Nevada State Dept. of Taxation and may not be allowed to take part in future shows in Nevada.
